The meeting was called to order by President Pete Cardamone at 5:30pm.

Agenda approved unanimously.

Minutes from the August meeting were reviewed. Patrice motioned, Denise seconded. Minutes were **approved** unanimously.

Treasurer's Report

- Reports received monthly by the board with a review of notable activity

 - ➤ Donations are down from what was budgeted and anticipated YTD. Utility bill was mistakenly unpaid for June/July all three months paid in August, and that oversight corrected. Only line items of note at this point.

 - 2) Policy currently states: "The aforesaid polices may not be modified or altered except by unanimous vote of the Trustees of the Tully Free Library at a meeting attended by a minimum of two-thirds of the then elected trustees."
 - 3) Current policy reads: The Board of Trustees of the Tully Free Library is desirous of establishing an Endowment Fund for the purpose of receiving contributions that will be used for capital improvements, upkeep, and maintenance of the Library.

- 4) Proposed amendment to Policy: (added text underlined) The Board of Trustees of the Tully Free Library is desirous of establishing an Endowment Fund for the purpose of receiving contributions that will be used for capital improvements, <u>real estate acquisition</u>, upkeep, and maintenance of the Library's real property.

Tully Free Library Endowment Fund

The Board of Trustees of the Tully Free Library is desirous of establishing an Endowment Fund for the purpose of receiving contributions that will be used for capital improvements, real estate acquisition, upkeep, and maintenance of the Library's real property.

BE IT RESOLVED, that said fund be created as of January 17, 1991 for the following purposes and with the following guidelines and restrictions:

- 1. The Fund will be known as The Tully Free Library Capital Endowment Fund
- 2. The Fund shall be maintained in a separate bank account and segregated from other Library funds.
- 3. The Board shall, from time to time, solicit contributions to the Fund.
- 4. All funds shall be invested to realize the highest reasonable return.
- 5. It is the hope that this Fund shall grow to an amount that will one day provide enough income for all capital improvements, maintenance, and upkeep at the Library.
- 6. All memorials made to the Library, unless otherwise specified, will go into this fund.
- 7. All fund principal plus a minimum of each years earned interest shall be retained in the fund.

The aforesaid polices may not be modified or altered except by unanimous vote of the Trustees of the Tully Free Library at a meeting attended by a minimum of two-thirds of the then elected trustees.
